

General Terms and Conditions of the University of Applied Sciences Technikum Wien (UAS Technikum Wien) for Applicants from Third Countries

1. Scope of Application

These general terms and conditions apply to applicants who are citizens of a third country and who, in a third country, have fulfilled the relevant admission requirements for studying at the UAS Technikum Wien.

Third countries are all countries (except Switzerland) that do not belong to the European Union or the European Economic Area.

Applicants who hold a secondary school diploma from an Austrian school abroad are also excluded from the scope of these General Terms and Conditions.

2. Deposit Requirement

If an application for a study program is sent by a person who meets the criteria under point 1, he/she will be requested by invoice to transfer a deposit of € 250.00 to the account of the UAS Technikum Wien. The transfer of the deposit must include the name of the person applying as well as the invoice number stated on the invoice. It is the responsibility of the applicant to ensure that the exact amount of € 250,00 is transferred to the account of the UAS Technikum Wien in the given time. Any fees, expenses and exchange rate differences will be borne by the third country applicants. Without exception, the application will only be reviewed if the deposit has been paid in full and the documents uploaded in the online application tool of the UAS Technikum Wien have been verified for proof of fulfillment of the admission requirements (§ 4 para. 4 FHG).

The payment of the deposit does not constitute a legal right to a study place at the UAS Technikum Wien!

3. Crediting of the Deposit against Tuition Fees

Applicants who are accepted for a place at the UAS Technikum Wien will have the deposit they have already paid credited to the deposit that is due upon acceptance of a study place.

Applicants who are accepted for a place at the UAS Technikum Wien but who withdraw their application before June 15 of the application year without giving any reason will have their deposit refunded.

Applicants who are accepted for a place at the UAS Technikum Wien, but who withdraw the place after June 15 of the application year, will not receive a refund of the deposit.

4. Refund of the Deposit

If the applicant does not obtain a place at the UAS Technikum Wien or withdraws the application during the current admission procedure, the deposit will be returned to him/her. In this case, the applicant will be asked once to provide the bank details from which he/she transferred the deposit amount to the FHTW. Repayment will be made within one month, without exception, only to the account from which the amount was transferred to the FHTW. Any fees, expenses and exchange rate differences will be charged to the applicant and will reduce the refund amount accordingly.

5. Retention of the Deposit

If the authenticity and correctness of the documents sent to prove the fulfilment of the admission requirements could not be determined after verification, the applicants are not entitled to a refund of the deposit according to § 4 para. 5a FHG.
